#### **Breakout Session 1**

1A) Know Your Student – Identity Verification in Higher Education, mitigating risk, protecting your reputation, and reducing costs

This session explores the hidden risks and compliance challenges in current identity verification practices for students, alumni, and collaborative partners. Delegates will examine policy gaps, assess institutional vulnerabilities, and discover emerging technologies, such as biometric tools and integrated digital platforms that enhance security, reduce errors, and strengthen institutional resilience.

Interactive discussion will highlight lessons learned, process optimisation, and approaches to sustainable, high-quality operations in a dynamic higher education environment.

#### 3B: Surviving a Crisis: The De-Designation of a Franchise Partner

This session provides a personal insight into BNU's response to a high-pressure franchise partner crisis. Delegates will explore how the institution managed regulatory challenges, assessed student 'genuineness' at scale, coordinated across multiple campuses and partner universities, and launched new campuses under intense scrutiny, all while balancing stakeholder priorities and executive responsibilities.

#### 3C) Growing a Service Culture, Catalogue & Community

Emma Bayne, Principal Consultant, Strivehigher



Understanding, navigating and accessing University services is fundamentally linked to student success, it is core to the experience. Moving to a service culture with a clearly defined service catalogue enables everyone to understand the 'what, how, who and when' of the service offer simply and easily.

Learn about the University of East London's award-winning journey to adopt a service approach, build a service catalogue, and to grow a university-wide community of practice to make positive change to support enhancing their student and staff experience now and into the future.



#### 3D) Fostering meaningful connections in challenging times

Lisa McDonagh, Teaching & Learning Manager (Teaching Excellence), The University of Manchester



This workshop explores how leaders can cultivate meaningful connections within their teams and across the sector. Through reflective exercises and discussions, delegates will engage with Professional Standards Framework (AdvanceHE), through touching on V5('In your context, show how you collaborate with others to enhance practice') and examine connection behaviours, the role of trust, and strategies to translate leadership ambition into genuine engagement and a culture of connection among diverse staff.

#### 3E) Fitness to Practise – lessons learned (sometimes the hard way)

James Dooley, Head of Student Case Management, Manchester Metropolitan University



This session explores the University's experience of centralising Fitness to Practise case management, handling around 90 cases annually. Delegates will learn how a consistent, impartial, and proactive approach reduces administrative burden, mitigates risk, and enhances student wellbeing. Key strategies include outreach, reflective practice, and relationship-building with academic departments, with practical insights for institutions considering similar reforms.

#### 3F: Automated Personalised Timetables - Who has time for that?

Nicholas Catterall, Interim Deputy Director of Academic Registry and Catherine Richards, Student Engagement and Exams Principal Officer, University of South Wales



This session presents the implementation of automated, personalised timetables at University of South Wales, highlighting the widening participation rationale, technical challenges, and tangible benefits for students. Delegates will learn how timely, detailed timetables improve planning and certainty, and discover the critical role of communication, resourcing, and shared vision in making automation and personalisation truly effective.

#### 4A) Ask Strathclyde: Enhancing Student Registration through Al-Powered Support

The University of Strathclyde showcases *Ask Strathclyde*, an Al-powered chatbot developed with Gecko to provide personalised, 24/7 support for students. Delegates will explore how the system improves efficiency, reduces staff workload, enhances service consistency, and delivers actionable insights, while demonstrating the impact of collaborative, innovative digital solutions on the student experience.

#### 4B) Freedom of Speech in Higher Education: Law, Practice, and Culture

Sam Rose, Principal Associate and Richard Sykes, Partner, Mills & Reeves

Further to the partial implementation of the Higher Education (Freedom of Speech) Act 2023 in August, this session will explore ways in which Higher Education Institutions in England might respond to the new regulatory expectations relating to freedom of speech, and the Office for Students' "Regulatory Advice 24 – Guidance relating to freedom of speech".

The event will outline the law, provide a platform for discussion, and an opportunity to work through practical examples on key likely trigger areas, such as international partnerships, protests, and equality, diversity and inclusion. Through discussion we will explore:

- How institutions can take reasonably practicable steps to secure and promote freedom of speech and academic freedom against the backdrop of existing legal duties; longstanding commitments to equality, diversity, inclusion; and institutional values.
- The status of, and how institutions should interpret and implement, the Office for Students' best practice advice, including the suggested three-step framework.
- How institutions can effectively manage complex communities in a way that supports fairness and respectful campus environments for staff and students, whilst encouraging a culture of robust debate.

Participants will have the opportunity to share their experiences and concerns in a guided discussion under Chatham House rules which will help them to gain insights into strategies for aligning institutional culture whilst meeting legal obligations, and staying on the right side of the regulator.

4C) Time Well Spent: Fixing the Future of the Kent Timetable (or) From Chaos to Clarity: Kent Transforming the Student Timetable

Kyra Harwood-Lucas, Assistant Director Academic Registry, The University of Kent



The University of Kent shares its journey of turning timetabling from a source of frustration into a streamlined, predictable, and student-focused process. Delegates will explore practical strategies for system alignment, stakeholder engagement, and change management, learning how early, clear, and structured planning improves both student experience and institutional efficiency.

#### 4D) Walking Away - Navigating Career Change in Higher Education

#### Julie Kelly and Lesley O'Keefe

This session provides a safe, reflective space to hear from experienced HE professionals who have left roles through voluntary severance, semi-retirement, or redundancy. Delegates will gain insight into the emotional and practical aspects of career transitions, exploring decision-making, challenges, and lessons learned, while connecting with others navigating similar experiences in today's financially pressured HE sector.



## 4E) Embedding care, wellbeing and professional standards into your practice: Lessons learned from Student Services

This session led by AMOSSHE, The Student Services Organisation, explores embedding care, wellbeing, and professional standards into academic registry practice. It brings together national recommendations and regulatory and legal duties for English providers to provide practical strategies to enhance student experience and institutional trust. It will also provide information on opportunities to embed wellbeing into your own practice and leadership.

4F) London Metropolitan's approach to working with collaborative partner organisations regarding the introduction of condition E6 - Harassment and Sexual Misconduct

In this session, we will provide a case study of the approach to the introduction of the ongoing condition of registration with our collaborative partner organisations both in the UK and globally.
